#### **6 QUALIFICATIONS**

World Taekwondo Demonstration & Breaking Championships is open to any individual who holds Kukkiwon Poom or Dan Certificate, the requirement is as mentioned. The age limit for each division is based on the year, not on the date, when the Championships are held.

- Individual Breaking – Open to all, Athletes aged over 14(15 and over)
- Demonstration performance – GAL (WT Global Athlete Licence) & Kukkiwon Poom or Dan Certificate, Athletes aged over 14(15 and over)

Contestants may compete up to two (2) categories of competition unless he or she is limited by gender or age.

#### **7 COMPETITION RULES**

The championships shall be operated by the Technical Guideline World Taekwondo Demonstration & Breaking Championships based on WT Poomsae Competition Rules & Interpretation in force as of September 30, 2024.

## 9 METHODS OF COMPETITION

### 9.1 Individual Breaking

- 9.1.1 Competition format: Cut-off system
- 9.1.2 Composition: 1 Individual
- 9.1.3 Competition duration: up to 1 minute - Jumping Multiple Kick & Vertical Spinning Kick  
up to 2 minutes - Free Style Breaking
- 9.1.4 Number of Boards: TBC
- 9.1.5 Scoring Criteria (Jumping Multiple Kick & Vertical Spinning Kick)
  - 9.1.5.1 Accuracy: 5 points
  - 9.1.5.2 Presentation :5 points
- 9.1.6 Scoring Criteria (Free Style Breaking)
  - 9.1.6.1 Accuracy: 40 points
  - 9.1.6.2 Presentation :40 points
  - 9.1.6.3 Level of Performance Skill: 20 points
- 9.1.7 Deductions & Disqualification
  - 9.1.7.1 Details related to the deductions and disqualification will comply with the regulations mentioned in the Technical Guidelines.
- 9.1.8 Tie-break
  - 9.1.8.1 Team with higher score of 5 referees combined, excluding the highest and the lowest will be the winner.
  - 9.1.8.2 If the tie persists, points on each kick defined in the Technical Guidelines will decide the winner.
  - 9.1.8.3 If the tie persists, team with higher combined score of 5 referees combined will be the winner.
  - 9.1.8.4 There will be rematch will take place to decide the winner.

\* Additional Notes

- Breaking boards will be provided by the Organizing Committee.

- Board holding sticks prepared by teams are only allowed for the acrobatic board breaking technique.
- Breaking board holders should be prepared by the team.

**9.2 Demonstration Performance**

- 9.2.1 Competition format: Cut-off system
- 9.2.2 Composition: 7 (including more than 2 males and 2 females)
- 9.2.3 Competition duration: within 5 minute (with 10 seconds allowance)
- 9.2.4 Scoring Criteria
  - 9.2.4.1 Yeonmu: 20 points
  - 9.2.4.2 Self-Defense: 20 points
  - 9.2.4.3 Breaking: 50 points
  - 9.2.4.4 Composition: 10 points
- 9.2.5 Deduction & Disqualification
  - 9.2.5.1 Details related to the deductions and disqualification will comply with the regulations mentioned in the Technical Guidelines.
- 9.2.6 Tie-break
  - 9.2.6.1 Team with higher points in Yeonmu will be decided as winner.
  - 9.2.6.2 If a tie still persists, team with higher point in Self-Defense will be decided as winner.
  - 9.2.6.3 If a tie still persists, team with higher combined score of 5 referees will be decided as winner.
  - 9.2.6.4 If a tie still persists after applying the above rule, both teams will be winners.

\* Additional Notes

- Each team is free to design their demonstration.
- Breaking boards will be provided by the OC.
- Music should be submitted on a USB with the team’s name at the head of team meeting.

**10 FIELD OF PLAY (FOP)**

- 10.1 Size: 12m x 12m Contest Area
- 10.2 Any matters related to the competition will be in line with the Demonstration & Breaking technical guideline.

**11 UNIFORM**

<i>Individual Breaking</i>	<i>Demonstration Performance</i>
Taekwondo Dobok	Not specified, Taekwondo Dobok or free uniform

- Hijab is allowed.
- Make up is allowed.
- Detailed specification of uniform is described in technical guideline.
- **In case of Taekwondo Dobok, only WT-recognized Dobok is allowed. Any contestant who wears unofficial Dobok will not be permitted to compete.**

**12 REGISTRATION**

i. WT Global Licence Registration

Athletes and Team officials participating in the *Individual Breaking* are able to participate **without** a WT Global Athlete License (GAL) or Global Official License (GOL), it is open to all. Registration link is as follow: [Registration for the Individual Breaking](#)

ii. WT Online Registration

A. Registration for Individual Breaking

1. All registration will be accepted through registration website provided by the Organizing Committee
2. An athlete is allowed to register up to two (2) divisions
  - i. For instance, an athlete is allowed to participate in Individual Breaking (Jumping Multiple Kicks) and Demonstration Performance

B. Registration for Demonstration Performance

1. Athletes outside of Korea – Registration will be accepted through GMS ([worldtkd.simplycompete.com](http://worldtkd.simplycompete.com)) with Global Athlete
2. Athletes within Korea – Registration will be accepted through registration website provided by the Organizing Committee

12.1 Entry Fees

- i. Entry deadline is June 30<sup>th</sup> 2025, 17:00 local time in Switzerland. Entry submission after this date/time will not be accepted under any circumstances.
- ii. Late replacement due to injury shall be handled case by case.

**Team officials:** Member national association can register online for maximum

- one (1) Head of team per country,
- one (1) manager per team,
- two (2) coaches per team,
- one (1) team doctor per team (medical doctor),
- one (1) trainer per team &
- three (3) Member National Association (MNA) officials per country can be registered online.

<b>2<sup>nd</sup> PLACE:</b>	SILVER MEDAL & CERTIFICATE
<b>3<sup>rd</sup> PLACES:</b>	BRONZE MEDAL & CERTIFICATE

\*Competition with less than four (4) countries or category with less than four (4) competed contestants cannot be recognized in the official results.

### 14 ANTI-DOPING

**14.1** The WT Anti-Doping Rules, and where necessary the Code of the World Taekwondo Anti-Doping, shall apply throughout the competitions.

**14.2** TUE (Therapeutic Use Exemption)

Athletes who take any substance or medicine listed in the “Prohibited List” of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact [tue@ita.sport](mailto:tue@ita.sport) to have it set up.

Otherwise, please download the TUE Application Form [HERE](#) and once duly completed and signed, send it together with the required medical file to [tue@ita.sport](mailto:tue@ita.sport) with copy to [antidoping@worldtaekwondo.org](mailto:antidoping@worldtaekwondo.org) by at least 30 days before the first competition day. ### 15 HEAD OF TEAM MEETING & DRAWING OF LOTS SESSION

**15.1** The head of team meeting and the drawing of lots session shall be conducted one (1) day prior to the start of the championships that is July 9<sup>th</sup>, 2025, in the presence of the WT officials and the representatives of the participating teams.

**15.2** The method of draw shall be decided by the Technical Delegate.

### 16 INDEMNITIES

**16.1** All officials and participants are covered with effective travel & medical insurance coverage.

**16.2** Participants without proper insurance coverage will not be allowed to compete at the championships.

**16.3** The Organizing Committee will acquire general Public Liability event insurance.

### 17 ACCOMMODATION
